## Training Agreement



Todd R. Baier, or any of his training staff, hereinafter referred to as the “Kennel” agrees to exercise due and reasonable care to keep its premises sanitary, properly enclosed and ventilated as the weather requires. The kennel will keep fresh, clean water available for the dog at all times and will feed a high-quality dog food on a daily basis. The kennel also agrees to keep contact with the owner as to progress in training and health of the dog. *\*\*The owner may require that the dog receive additional food, medications, and supplements as noted below. Owner will provide such items or be billed additionally.*

### **Records:**

The owner will supply proof of immunization for Rabies, Distemper Hepatitis, Parvovirus, Coronavirus Adenovirus and Bordetella. The dog will be current on a Heartworm preventative. A link for submitting proof of immunizations will be sent to the owner and must be completed prior to drop-off. The owner warrants that the animal has *not* been exposed to distemper or rabies within the last thirty (30) days.

### **Training Evaluation Period:**

The training evaluation period is 3 weeks. During that period, the kennel will evaluate the dog as to its ability to reach the owner’s training goals. At the conclusion of the period the Kennel will schedule a call with the owner to share their findings. The kennel will also share their projected timeline.

For the Training Evaluation Period the owner will pay the daily rate of the requested training. An invoice for the Training Evaluation Period will be sent prior to drop-off and must be paid in full before drop-off. If you wish to pay via check or cash at the time of drop-off, please notify the kennel.

### **Financial Commitment:**

The animal is here for training at the rate of \$294.00 per week(\$42/day) for Hunting Dog Training or \$350.00 per week (\$50/day) for Advanced Retriever Training.

Owner’s will be sent an invoice at the end of each month, and payment is due within 5 days of receipt. A daily late charge of \$10 will incur, after the 5-day window has lapsed, until full payment is made.

Payment can be made using a credit/debit card via the invoice sent, if you wish to pay via cash or check, please notify the kennel at the beginning of the billing period. In the event of a returned check, a return fee of \$35 will be assessed along with a daily charge of \$10 until full payment is made.

The animal may not be removed from the kennel until all fees are paid in full. The kennel shall have and is hereby granted a lien on the aforesaid animal for all unpaid fees thirty (30) days after such fees are due and payable.

The owner guarantees payment of all fees. If for any reason the fees are not paid when presented and are placed in the hands of an attorney for collection, the owner agrees that the additional expenses may be added for attorney fees and other such costs as the court may allow.

***This fee includes***, food, board, pigeons for training, routine procedures such as: ear flushing, nail trims, and bathing when necessary.

***Additional costs***, if the owner elects to have their animal participate in any NAVHDA test, or any other sanctioned test or trial, the owner will be billed for the test fee and any associated costs. Such as: travel, lodging, organization registration, etc... For training that involves birds other than homing pigeons the owner will be billed based on the number of birds used, species of birds used, and current market value of birds used. Bird costs are in addition to the monthly training fee.

**Veterinary Care:**

If the animal becomes ill, the owner shall be notified at once, or such attempt shall be made to do so. If the owner cannot be reached or does not immediately inform the kennel regarding the measures to be taken or if the state of the animal's health requires quick action, the right to call a veterinarian, to administer medicine or to be given advisable attention within the discretion shall taken by the kennel. Such expenses shall be paid by the owner.

The kennel does not assume and shall not be held responsible for any liability with respect to the animal listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from the training, boarding of this animal, or any damages which may accrue from any other cause whatsoever, including loss by fire, theft, running away, or death.

The Owner hereby acknowledges having read this contract and agrees to its content.
